Revised Grant Application Procedure

The Greenwich Collection, Ltd. has revised its grant application procedure. If you wish to submit an application, please note our new requirements as below:

1. All grant applications must be received as hard copy mailed to 637 Greenwich Street, New York, NY 10014, between September 1 and September 30.
2. The application must be headed Grant Application on one side of one sheet of letter-size paper, and include:
 - A) All contact information.
 - B) A brief statement outlining the history and goals of your organization.
 - C) The purpose of the grant. You may apply for general operating expenses, but TGCL favors applications for specific projects.
 - D) The sum requested.
3. You may include other pertinent information in any format.

The Board generally reviews applications in the late Fall; you may expect a response before the end of the calendar year.
